Ideally located within a mile of Hither Green, Lee, and Blackheath stations, the property offers excellent commuter connections into Central London. Families will appreciate the proximity to highly regarded local nurseries and schools, including Brindishe Lee Primary, while the much-loved Manor House Gardens — with its lake, tennis courts, café, and playground — is just a short stroll away.


